Qualified Entrant and Entry

- A qualified Entrant (“Entrant”) is 19 years of age or older and has earned a ballot (“entry”) by complying with the “**Contest Details for Poker Fast Cash**” and “**How to Earn Entries into the Draws for Poker Fast Cash**” sections below.
- The following persons are not eligible to participate in the contest and, thus, cannot be Entrants:
 - Employees of Casino Victoria and its subsidiaries and affiliates (collectively, “CASINO VICTORIA”), and the British Columbia Lottery Corporation (“BCLC”), as well as family and household members who reside at the same address.
 - Voluntary self-excluded (participating in Game Break), CASINO VICTORIA site barred and BCLC provincial barred persons, and residents of Québec. Entrants and Entries must meet and adhere to all contest rules as outlined herein. Entrants and/or Entry not meeting such rules will be disqualified and any potential prize will be forfeited.
- A qualified contestant (“Contestant”) is any entrant who has been selected based on the “**Draw Procedure for the Poker Fast Cash**” section embedded within.
- A qualified winner (“Winner”) is a contestant who wins a prize by complying with the “**Prize Claiming Conditions for Poker Fast Cash**” and “**General Conditions**” set out below.
- CASINO VICTORIA reserves the right in its sole discretion to determine whether any person is qualified to be an Entrant or disqualified to be an Entrant, and to disqualify any persons who, in the sole discretion of CASINO VICTORIA, act inappropriately at CASINO VICTORIA facilities or in connection with the contest, including but not limited to persons who interfere with, tamper with, or inappropriately affect the business of CASINO VICTORIA or the administration of the contest.

Contest Details for Poker Fast Cash

- The Contest Period runs from **10:00AM PT Monday, April 6, to 8:00PM PT Sunday, June 28, 2026**.
- Prize Draws will take place **every Sunday at 8:00PM PT**.
 - **The first draw will take place Sunday, April 12, 2026**
- There are a total of twelve (12) prize draws during the promotional period.

Prizing for Poker Fast Cash

- Each draw day will consist of one (1) \$1,000 prize. (\$500 Cash and \$500 Table Bonus Play)

Draw Day	8:00PM
Sundays	\$1,000 (\$500 Cash + \$500 Table Bonus Play)
Total Prize Pool	12,000 (\$6,000 Cash + \$6,000 Table Bonus Play)

- **Bonus Play Prizing will be issued with CMP Code: VIC-PFC_WTBP**

How to Earn Entries into the draws for Poker Fast Cash

There are **two ways** to enter the **draws**: Earning Entry through Slot Play, or with a “Self-Addressed-Stamped Envelope” alternative.

1. Earning Entry through Poker Play:

- One (1) ballot can be received by an Encore Rewards member or uncarded Entrants on each of the participating promotional days (Monday through Sunday each week) with active play of one hour.
- Players must have one hour of active play at the poker table to be eligible for a ballot.
- One (1) ballot can be earned for each hour of active play each day.
- Earned ballot(s) must be deposited into the assigned draw barrel prior to the start of the draw.
- An eligible ballot will include the Entrant’s First Name, Last Name and Encore Rewards Number or their Telephone Number. If anyone (1) of these three (3) fields is not included, the ballot will be deemed invalid and a redraw will occur.

- The draw location and draw barrel will be nearby the Poker Tables.

2. “Self-Addressed Stamped Envelope” Entry (“SASE Entry”)

- No purchase necessary. Anyone may request one (1) Entry in writing by delivering a self-addressed, stamped envelope (which must be received during the Contest Period) to “**Poker Fast Cash**” c/o **Elements Casino Victoria Guest Services, 1708 Island Hwy, Victoria, BC V9B 1H8**. The Entry must include their full name, Date of Birth, phone number, and Encore Rewards number. The entrants are responsible to ensure that entries arrive on time; as set out below, CASINO VICTORIA is not responsible for any lost, misdirected, or incomplete entries.
- Entries by the SASE Entry are limited to one (1) Entry per Entrant for the Contest Period.

Draw Procedure for the Poker Fast Cash

Two (2) registered CASINO VICTORIA gaming employees will conduct draws:

- One (1) entrant will be selected at random through the ballots that were entered into the draw.
- Eligible entrants must have engaged in play on the day of the draw.
 - Table Game Dealer Supervisors will be responsible for tracking all guests who have played on the table on the date of the draw.
- Once a player is selected, the Drawn Entrant’s names will be announced via PA system multiple times and Contestant is required to identify themselves within two (2) minutes of the first announcement.
- If no winner is present for the draw, a redraw will occur. Within each redraw, one (1) unique name will be drawn.
- There will be an unlimited redraws until a winner has been confirmed and verified.
- If there are no more eligible ballots in the draw barrel during one of the draws, the prize will be carried forward to the next draw date.
- If a(n) uncarded Entrant(s) is selected, they must have the same identification to claim prize.
- The prizes will be awarded in the form of cash.
- **Draw barrel is cleared at the conclusion of each of the weekly draws, following the 8:00PM draw.**
- Entrant(s) must be present to win.

Prize Claiming Conditions for Poker Fast Cash

- To become a Winner, a Contestant must:
 - be nineteen (19) years old or older on the date on which the prize is granted.
 - Present valid government issued photo ID establishing the identity of the holder in the sole discretion of CASINO VICTORIA, such as a driver’s license, passport, or citizenship card.
- Eligible entrants must have engaged in play on the day of the draw.
 - Table Game Dealer Supervisors will be responsible for tracking all guests who have played on the table on the date of the draw.
- Prizes must be accepted as awarded, no substitutions, exchanges, refunds, or transfers.
- Prizes will be awarded in the form of Cash or bonus play during the promotional period.

- Gaming day is from 7:00am PT to 6:59am PT.
