Qualified Entrant and Entry

Tournament Details for \$40,000 VIP Slot Tournament

- Participating Sites: Elements Casino Victoria
- The Qualifying Period runs each month on Tuesdays & Wednesdays from 2PM – 10PM.
- There will be a total of **three (3) qualifying periods**:
 - March 3 – March 25 (4 weeks)
 - March 31 – April 29 (5 weeks)
 - May 5 – May 27 (4 Weeks)
- The **top sixteen (16)** players of each qualifying period will move on to the monthly Semi-Finals.
- The Semi Finals will run at the end of each month’s qualifying period. They will take place on the final Thursday from 2PM-10PM for a total of 3 semi-finals.
 - Thursday, March 26 | 6-8PM
 - Thursday, April 30 | 6-8PM
 - Thursday, May 28 | 6-8PM
- The Grand Finale takes place at **2:00PM PT Sunday, May 31st**.

\$40,000 VIP Slot Tournament – Qualifying Rounds

Qualifying Rounds - Details

- This Slot Tournament is open to all Elite and VIP members.
- One free entry will be available to all Elite and VIP members each **Tuesday & Wednesday of the qualifying period**.
- Players that are interested in participating in the \$40,000 VIP Slot Tournament can do so at the Everi banks.
- This is a Sit-And-Go style Everi Tournament which will be programmed to activate when a player sits at the bank and inserts their encore card.
- Qualified players can participate anytime between 2PM and 10PM on Tuesday & Wednesday during the qualifying period.
- Entrants will be given three (3) entries per qualifying day.

- Tournament will be configured for max score, so the player's top score out of all their attempts will count towards semi-final qualifications.
- Guest Services will use a CMP code to track the top sixteen (16) players. **VIC-VIPSEMI**

Qualifying Rounds – Tournament Play

- The Sit-And-Go style Everi Tournament will be preset on the machines to run each week.
- For each qualifying round, The Tournament will be manually started at 2PM and paused at 10PM on the designated tournament days.
- Players will have the opportunity to play the 2-minute game: **Mardi Gras Party**
- **At the end of each qualifying week, the top five (5) will receive Bonus Play Prizing**

Qualifying Rounds Prizing

- Each Qualifying Week, the top five (5) players at Elements Casino Victoria will receive a share of the \$2,000 Bonus Play Prize Pool.

- At the end of each qualifying period the top sixteen (16) scores will earn a spot in the Semi-Finals.
- A semi-finalist can earn only one (1) semi-finalist spot during a qualifying month.
 - A player can earn a total of 3 semi-finalist spots, one for each month.
- Players **will not** be able to earn multiple entries to the same month's semi-finals.

Semi-Finals – Details

- The Semi Finals will run at the end of each month's qualifying period. They will take place on the final Thursday each month for a total of 3 semi-finals.
 - Thursday, March 26 | 6-8PM
 - Thursday, April 30 | 6-8PM
 - Thursday, May 28 | 6-8PM

Qualifying Rounds – Tournament Play

- One (1) multi-round group tournament, configured for Session Winner advancement, with the top five (5) players advancing from each session to Round 2. (the Grand Finale)
- Round 1 will consist of three (3) sessions, representing each monthly Semi-Finals.
- Operator will import the top sixteen (16) players from the qualifying tournament into the first session. This can be done through Everi or using the **VIC-VIPSEMI**.
- The top five (5) players winning session prizes and advancing to Round 2. After the March semi-final, the tournament must be paused until it's time for the next Semi-Final, and the process repeats until all three Semi-Finals are complete.
- **All players participating in Semi-Final tournaments should be encouraged to attend the Grand Finale whether they qualify or not, as there will be at least one Wildcard player drawn to fill the 16th spot in the final (or more in the case of no-shows).**

Again, players will have the opportunity to play the 2-minute game: **Mardi Gras Party**.

- A semi-finalist can earn up to **one (1)** spot in the Finale during the semi-finals.
 - Please use the following CMP code to register the player into the Finale: **VIC-VIPFINAL**
 - If a player is unable to attend the Grand Finale on Sunday, May 31 at Elements Casino Victoria, their invite will be passed along to the next eligible player. However they will still receive their bonus play.
 - For example, if Player A secures a 5th-place qualification but cannot participate in the Grand Finale, their spot will then be offered to the player who finished in 6th. Bonus Play will still go to the player that finished in 5th originally.

Details

- The finale will take place on **Sunday, May 31** at Elements Casino Victoria.
- Only invited finalists will be eligible to participate in the finals.
- The finale will be a roped off Everi Tournament beginning at 2PM.

Grand Finale – Check - In

- The full list of Entrants will be scanned through iTrak Prior to the Tournament.
- Check-in desk will open at 1:00PM PT.
 - All players must check in at least fifteen (15) minutes before the finale and remain in the tournament area.
 - To check-in for the Tournament, players must present their Encore Rewards card, along with a valid Government-issued ID.
- Prior to the tournament commencement, Entrants will be informed of following Tournament mechanics by the Tournament Coordinator:
 - A random machine will be generated for them to play on during their session.
 - Each Entrant will have:
 - One (1) session to play in the Tournament.
 - A qualified Entrant who has launched the Tournament will play the game to completion.

Grand Finale – Wildcard Draw

- There will be one guaranteed wild card draw for the sixteenth (16) and final spot in the Finale.
