Qualified Entrant and Entry

- A qualified Entrant ("Entrant") is 19 years of age or older and has complied with the "**Contest Details for Senior's Day Slot Tournament**" and "**How to Earn Entries into the Draws for Senior's Day Slot Tournament**" sections below.
- The following persons are not eligible to participate in the contest and, thus, cannot be Entrants:
 - Employees of CASINO VICTORIA Entertainment and its subsidiaries and affiliates (collectively, "CASINO VICTORIA"), and the British Columbia Lottery Corporation ("BCLC"), as well as family and household members of same who reside at the same address;
 - Voluntary self-excluded, CASINO VICTORIA site barred and BCLC provincial barred persons; and Residence of Quebec.

Prize Claiming Conditions for Senior's Day Slot Tournament

- To become a Winner, a Contestant must:
 - be nineteen (19) years old or older on the date on which the prize is granted.
 - Present valid government issued photo ID establishing the identity of the holder in the sole discretion of CASINO VICTORIA, such as a driver's license, passport, or citizenship card.
- **An entrant can win a maximum of one (1) slot tournament prize during the promotional period.**
- Prizes must be accepted as awarded, no substitutions, exchanges, refunds, or transfers.

How to Earn Entries into the Slot Tournament

There are **two ways** to enter the **draws**: Earning Entry through Slot Play, or with a "Self-Addressed-Stamped Envelope" alternative.

Slot Players Sign Up

- Guests aged 65+ may sign up for the Everi Slot Tournament at Guest Services with two valid pieces of ID.
- Entrant(s) must be Encore Rewards members to qualify.

"Self-Addressed Stamped Envelope" Entry ("SASE Entry")

- No purchase necessary.
